

## FANS COMPETITION TERMS AND CONDITIONS

### 1. DEFINITIONS

- 1.1 **"Competition"** means the Fans Competition more fully described in the competition details;
- 1.2 **"disqualified entrant"** means all Promoter employees, directors, and consultants all employees of participating sponsors, promoters, and/or advertising agencies, and their immediate relations as well as persons not in attendance at the event;
- 1.3 **"Entrant"** means the party entering the competition;
- 1.4 **"Event"** means the event to be held on Saturday, 27 February 2016 at Sea Point Promenade, Cape Town, Western Cape
- 1.5 **"immediate relations"** means spouses, grandparents, parents, children, and grandchildren whether by marriage, past marriages, remarriage, adoption, co-habitation, or other family extension;
- 1.6 **"Prize"** means:
- 1.6.1 2 (two) return economy class flights from Cape Town to Spain (including all fares and taxes);
- 1.6.2 2 (two) nights' accommodation for 2 (two) guests, including breakfast;
- 1.6.3 2 (two) tickets for a football / soccer match next season of the Winner's choice, **excluding matches Real Madrid CF vs FC Barcelona and FC Barcelona vs Real Madrid FC** (subject to these terms and conditions);
- 1.6.4 100€ (one hundred Euro) per day for meals;
- 1.7 **"Promoter"** means Liga Nacional de Futbol Profesional (LaLiga), its holding and subsidiary companies, and all affiliated entities in the La Liga Group including all brands and operating companies controlled by or associated with those entities;
- 1.8 **"these terms and conditions"** means the rules, terms, and conditions of the Competition set out in this document;
- 1.9 **"qualified entrants"** means:
- 1.9.1 citizens and residents of the Republic of South Africa;
- 1.9.2 who are not disqualified entrants.

### 2 PRELIMINARY

- 2.1 These terms and conditions can be accessed at [www.laliga.es/en](http://www.laliga.es/en).
- 2.2 The Competition details form part of these terms and conditions.
- 2.3 The Promoter reserves the right to amend, vary, extend, or discontinue a Competition at any stage, for any reason.
- 2.4 These terms and conditions will be interpreted in accordance with the laws of the Republic of South Africa.

### 3 ENTRY

- 3.1 Only qualified entrants may enter the Competition.
- 3.2 The competition must be entered into by the Entrant personally at the Event.
- 3.3 To be eligible to win the Prize, the Entrant must remain at the Event for the duration thereof until the Winner is announced and must at all times comply with these terms and conditions.
- 3.4 Entrants are required to fill in the competition form overleaf by correctly answering the question stated thereon (*Name the first and last name of the Real Madrid captain*) and by providing accurate full legal names, cell phone number, e-mail address, and confirming acceptance of these terms and conditions.
- 3.5 Entries that are incomplete, illegible, indecipherable will not be valid and will be deemed void.
- 3.6 Entry is limited to 1 (one) entry per Entrant.
- 3.7 The Competition opens at 13:00 and closes at 17:00 on Saturday, 27 February 2016.
- 3.8 The Promoter accepts no liability for entries not received for whatever reason.
- 3.6 The Promoter reserves the right to exclude any Entrant from participating in the Competition and may refuse to award any prize on reasonable grounds and further reserves the right to take legal action against any Entrant that manipulates or otherwise falsifies the Competition
- 3.7 The Entrant grants to the Promoter exclusive permission to use the Entrant's names, characters, photographs, videos, voices, other biographical, and likeness in connection with the Competition and for future promotion and marketing purposes. The Entrant accordingly releases the Promoter and waives any claims to royalty and right or remuneration for such use.
- 3.8 All Entrant's personal details must be valid and up to date at the time of entering the Competition and will be held by Promoter and may be used for the purpose of the Competition and for future promotion and marketing purposes.

### 4 WINNING THE PRIZE

- 4.1 Only an Entrant can be awarded and accept the Prize ("the Winner").
- 4.2 The Winner will be determined by a random draw. The first draw with the correct answer will be the Winner.

- 4.3 The determination of the Winner will be final and no correspondence will be entered into.
- 4.4 The Winner will be notified at the Event in person and must be available for the preparation of all publicity that may be required by Promoter.
- 4.5 Where reasonable attempts to contact the at the event Winner fail, another Winner will be selected.
- 4.6 The Prize is subject to availability and the Prize suppliers' terms and conditions.
- 4.7 The Prize is not redeemable for cash or transferable.
- 4.8 The Winner must take the Prize as stated and no compensation will be payable if the Winner is unable to use the Prize as stated.
- 4.9 In the event that the Prize becomes unavailable for any reason, the Promoter may substitute a prize of like or equal value.
- 4.10 Where the Prize is to be supplied by an entity outside of the Promoter's control and that entity fails, for whatever reason, to supply the Prize, the Promoter has no responsibility for the provision of the Prize and is not obliged to provide an alternative Prize or to take legal action to require the Prize supplier to provide the Prize or to substitute the Prize with a prize of like or equal value.
- 4.11 The Winner takes the Prize entirely at his/her own risk and indemnifies Promoter in respect of any claim for any accident, injury, property damage or loss of life that may occur in connection with the Prize.
- 4.12 The Winner is responsible for all costs associated with obtaining necessary travel documents, passports, and visa application fees, travel insurance, tax, or other costs and expenses that are not expressly included in the description of the Prize or that may otherwise be associated with the Prize.
- 4.13 As the Prize includes international air travel and accommodation, the Winner must have valid travel documentation, including but not limited to valid passports and visas that meet the requirements of immigration and other government authorities at every destination of the Prize.
- 4.14 Any fines, penalties, payments, or expenditures incurred as a result of such documents not meeting the requirements of those authorities (including any costs associated with delay, will be the sole responsibility of the Winner).

### 5 THE WINNER

- 5.1 The Winner will be required to compile a video blog of their participation in the Prize.
- 5.2 If the Winner is under the age of 18 (eighteen) years, the Winner's parent or legal guardian must deliver to the Promoter written consent for the Winner to accept the Prize by 17:00 on Friday, 4 March 2016. When undertaking international travel, the Winner must be accompanied by his or her parent or legal guardian, alternatively, must undertake such international travel with a travel companion who is older than 18 (eighteen) years of age with the parent or legal guardian's written consent, which is also to be delivered to the Promoter before such international travel.
- 5.3 The Winner is responsible for transport from their residence to their nearest international airport for departure and from their nearest international airport to their residence upon their return.
- 5.4 Any changes to travel dates or additional accommodation outside the travel period specified in the Prize details, made by the winner that incur additional costs, are to be paid by the Winner.
- 5.5 The Winner will be responsible for all expenses not expressly included in the description of the prize including, but not limited to, spending money, meals, drinks, transport, laundry charges, activities, incidentals, taxes (excluding departure and any other flight associated taxes included in the Prize), gratuities, services charges, passports, visas, travel insurance, and all other ancillary costs associated with redeeming the Prize.
- 5.6 The Winner must obtain travel insurance to protect themselves against additional costs incurred in the event of unforeseen circumstances.
- 5.7 If the Winner is for whatever reason unable to travel on a nominated date, whether the failure is owing to reasons beyond the Winner's control or otherwise, then the Winner will forfeit the Prize and the Promoter reserves the right to select an alternative Winner.
- 5.8 The Promoter makes no representation as to safety, conditions, and other issues that may exist at any destination.
- 5.9 All travel is subject to the terms, conditions, and restrictions of the Prize service providers.
- 5.10 Any travelling companion included in the Prize (if applicable) accepts the Prize subject to these terms and conditions as if references to the Winner in the relevant clauses were to the travelling companion.
- 5.11 The Winner and their travelling companion must sign a legal release, in a form acceptable to the Promoter in its absolute discretion, if requested by the Promoter.
