If not registered, they must complete the registration form by filling in all required fields and accept the privacy policy. • Once the above steps are completed, participants will receive an email at the address provided (double opt-in validation) with a link to activate their account. • If already registered, users must log in using their email and password. • Participants must have a team in LALIGA Fantástica or LALIGA Fantasy and it must be public. Users who have their team within a league sponsored by an entity other than Cadena SER may not participate in the Promotion. • Participants must join one of the leagues sponsored by Cadena SER and accept the mandatory legal consents.

2. GENERAL TERMS

2.1. Organizer

This Promotion is organized by SOCIEDAD ESPAÑOLA DE RADIODIFUSIÓN, S.L.U., with registered address at Gran Vía 32, 28013 Madrid (Spain) and N.I.F: B28016970, registered in the Madrid Mercantile Registry (en adelante, SER o el Organizador).

2.2. Participation Requirements

Participants must:

- i. Be over 18 years old
- ii. Reside in Spain
- iii. Not be employees of the Organizer or involved in the Promotion
- iv. Not be first-degree relatives of excluded persons
- v. Possess a valid ID document
- vi. Fully accept these Terms
- vii. Accept the conditions of the participation channel

Any participant attempting fraud, manipulation, or unfair advantage will be disqualified.

The Organizer reserves the right to disqualify participants who publish offensive, illegal, or inappropriate content.

Any participant who attempts to illegally alter their registration and/or participation, falsify the results, and/or use fraudulent methods of participation, through any technical or computer-based procedure, and/or who in any way undermines or violates equal opportunities among all participants (such as, for example, participating repeatedly with different profiles or user accounts), will be disqualified from the Promotion.

The Organizer reserves the right to disqualify from the Promotion any participant who does not comply with these Terms and Conditions or who publishes any defamatory, libelous, obscene, threatening, xenophobic, or discriminatory content, or content that incites violence or violates the law, morality, public order, honor, privacy, or image of third parties.

2.3. Prizes

2.5. Acceptance of Terms

2.6. Personal Data Processing

2.6.1. Common Information for All Participants

The personal data provided by participants will be processed by the Organizer, acting as the data controller, for the purpose of managing participation in the Promotion in accordance with these Terms and Conditions (General and Specific). The legal basis for this processing is the necessity for managing the Promotion as set forth in these Terms and Conditions (General and Specific).

The personal data of participants will not be disclosed to any third party, unless necessary for managing the Promotion in accordance with these Terms and Conditions (General and Specific). Participants' personal data will be processed for the duration of the Promotion and subsequently retained for one month in case of any issues.

Participants may exercise their rights of access, rectification, erasure, objection, restriction of processing, and data portability by contacting the Organizer by mail at the address provided, sufficiently proving their identity and identifying themselves as a participant in this Promotion.

It is recommended that users provide all the necessary information to ensure their request is properly addressed. Furthermore, if a participant believes their data protection rights have been violated, they may contact the Data Protection Officer voluntarily appointed by the PRISA Group, to which the Organizer belongs, at dpo@prisa.com, explaining their case in detail and providing all the necessary information to resolve it. 2.6.2. Third-party data:

2.6.3. Specific information for winners and reserves
